## Nursing Home Case Result

Take the case of Charleen, who passed away in November 2018. She was a resident of L Rehabilitation, a for-profit nursing center in a town north of Boston in Massachusetts. Charleen was 76 years old when she fell from her wheelchair in September 2018, sustaining cervical spine fractures that led to a quick decline in her health, and her death a couple months later. Charleen's family brought claims against L Rehabilitation Rehabilitation for putting profit over safety when they admitted Charleen, despite not being able to implement prevention planning for falls. The grieving family received \$450,000 as compensation for the loss of their loved one due to L Rehabilitation's negligence.
